

## Informed Consent, Release, Indemnity and Media Authorisation Agreement

The Participant identified below ("Participant") desires to participate (as a team member, coach, mentor, judge, volunteer, or in some other manner) in any of the events (the "Events") organized by World Robot Olympiad Association ("WRO") and any third party designated and approved by WRO (the "Partner") (WRO and the Partner are collectively, the "Organisers").

As a condition of *allowing* Participant to participate in an Event, the Organisers require that the Participant (by his or her Parent/Guardian if under 18 years of age) agree to the terms of this Consent and Release Agreement.

1. The Organisers shall endeavour to provide a reasonably safe environment in which the Events are carried out, there may nevertheless be risks associated with the Events. Accordingly, the Participant (or the Parent/Guardian of a Participant under 18 years of age) agrees that his or her participation in the Events shall be done entirely at the Participant's own risk and the Participant shall be deemed to have understood the risks and conditions associated with the Events. Participant, if 18 years of age or older, acknowledges and agrees that he/she is primarily responsible for his/her safety. The Parent/Guardian of a Participant under 18 years of age acknowledges and agrees that the Parent/Guardian is primarily responsible for the Participant's safety and that the Parent/Guardian will monitor, as appropriate considering the age of the Participant and other factors, the Participant's participation in the Event. The Participant further agrees not to hold liable, the Organisers, their respective subsidiaries, employees and agents, to the extent permitted by law, for any death, personal injury, loss or damage arising out of the Participant's participation in the Events whether in contract, tort (including negligence or breach of statutory duty) or otherwise.

2. Participant (and the Parent/Guardian of a Participant under 18 years of age) understands that live broadcasts, photographs, videotapes, and other recordings may be made of all participants in the Events, including the Participant's likeness, voice and sounds. Participant (and the Parent/Guardian of a Participant under 18 years of age) consents to those broadcasts, photographs, videotapes, and other recordings and the use thereof (i) as part of a record of the Program and (ii) to promote WRO and the Events in any and all media for any purpose, including advertising and other promotions, without compensation to the Participant or his/her parent or guardian. The Organisers may use the Participant's information for their programs and promotions.

3. The Participant (or the Parent/Guardian of a Participant under 18 years of age for and on behalf of the Participant and the Parent/Guardian) consents to the collection and processing of personally identifiable data, of the types and for the purposes expressed in the WRO Privacy Policy. The participant (or the Parent/Guardian of a Participant under 18 years of age) acknowledges they have read, understand, and affirmatively consent to the WRO Privacy Policy.

4. The Participant (or the Parent/Guardian of a Participant under 18 years of age for and on behalf of the Participant and or the Parent/Guardian) shall indemnify the Organisers for (i) any damage to property, loss, expense or cost suffered by the Organisers; and (ii) against any claim made by any third party against the Organisers and from any expense or cost incurred by the Organisers in the event they are held liable for damages in respect of such claim by reason of or arising out of any injury, death, damage to property, loss, expense or cost occurring to any person which is caused by or as a result of any act or omission of the Participant.
